ALPHA-ARBUTIN is a biotechnologically produced pure, water-soluble, crystalline, white to off-white powder for cosmetic application.



Stability and Storage

ALPHA-ARBUTIN may be stored for at least 36 months from the date of manufacture in the unopened original container protected from light and humidity in a clean place and at a temperature between 15 and 25°C. The 'Best use before' date is printed on the label. Keep package tightly closed. Once opened, use contents quickly. In order to avoid secondary microbial contamination, following opening, containers should be handled with special care.

Uses

ALPHA-ARBUTIN is a cosmetic ingredient for skin care products. It should be processed at a maximum temperature of 40°C and incorporated into the aqueous phase of a cosmetic formulation. For face and neck care preparations up to 2% of ALPHA-ARBUTIN and for body care preparations up to 0.5% of ALPHA-ARBUTIN may be used.

This product is safe for the intended use. Avoid ingestion or direct contact by applying suitable protective measures and personal hygiene.
